Rendering sand is a fine-grained sand that has been washed to remove silt, salt, and clay that could be found within the sand. By washing the sand it will allow a smooth finish and help to reduce both cracking and shrinking when dried. The grains within the Rendering Sand will be smooth and rounded, with no sharp edges.

Aggregate Industries Rendering Sand can be used with a blend of cement to create a coat of render on exterior walls, which can be used to give an attractive look.
